Tasia Hill (DOB 10/16/1999) by her DAVID photo, with multiple fresh cuts, bruises, and a black eye walked into the store and requested that they call 911 for her. Tasia stated her husband harmed her and she was in fear for her life and proceeded to lock herself in the women's bathroom. Tasia was with her husband, who was later positively identified as Korarise Hill (DOB 07/29/2001) by his DAVID photo, who was inside a silver in color Chevrolet vehicle parked at pump 11. The employee was unable to observe the license plate at this time. Flagler County Fire Rescue arrived at Circle K due to the injuries reported. Flagler County Fire Rescue notified Flagler County Emergency Communication for Law Enforcement to elevate their response due to Korarise still at gas pump 11.

Deputy J. Dorsey arrived at the scene and began to approach the previously described vehicle at pump 11. On the sight of Deputy J. Dorsey, the Korarise fled from Circle K. Korarise failed to stop for Law Enforcement upon activating their lights and sirens in a marked patrol vehicle. The vehicle was later identified as a silver Chevrolet bearing Florida temporary tag #RUQQ68. An authorized pursuit ensued after charges were established. See Deputy J. Dorsey's and Deputy Barlotta's Supplemental Narrative report for further.

I made contact with Tasia who was actively being treated by Flagler County Fire Rescue for her fresh injuries. Tasia advised me of the following:

Tasia and Korarise are currently married and homeless but were staying with Korarise's grandmother's residence located at 4511 Richard Allen Street, Sanford, FL. At an unknown time earlier in the day, Tasia and Korarise were inside the parked vehicle when Korarise was looking through Tasia's cell phone. Korarise observed evidence of infidelity and became violently upset. Tasia was in the driver's seat and Korarise was in the front passenger seat. Korarise began to strike Tasia repeatedly with a closed fist in the head and face area. Korarise slightly stood up in the passenger seat and struck Tasia with his foot in the upper chest and head area. Korarise then presented a green in color handgun and pointed it at her head. Korarise stated that he would kill her. Korarise struck Tasia with the handgun in the



forehead. Korarise placed his hand around her neck and squeezed as hard as he could. Tasia advised she could not breathe and restricted her airway. Korarise continued to strike her with a closed fist while his other hand was around her neck. Tasia advised that she "was gushing blood" and during the incident she "blacked out".

Korarise stopped striking Tasia and demanded that she drive to Palm Coast, FL to his other grandmother's residence, Adlena Lowe (DOB 09/22/1960) located at 9 Wilmart Place, Palm Coast, FL. Tasia was constantly struck by Korarise during the entire drive from Sanford to Palm Coast with a closed fist in the head and face area. Once Tasia arrived at 9 Wilmart Place, Korarise stated "If you try anything stupid, you will die". Tasia truly believed he would harm her if she attempted to leave the vehicle due to the recent violent attack with a firearm, so she remained in the vehicle. Korarise took the key to the vehicle so Tasia could not leave and entered the residence. Shortly after Korarise entered the vehicle again and demanded Tasia drive her back to Sanford but to stop at a store to purchase a Black and Mild. Tasia arrived at Blaze and Flame smoke shop, 4845 Belle Terre Parkway, Palm Coast, FL. Korarise again removed the vehicle key so Tasia could not leave and entered the store. After Korarise reentered the vehicle, he stated to drive back to Sanford. Tasia informed Korarise that she needed to purchase gas and the Circle K was next to Blaze and Flame smoke shop. Tasia parked at gas pump 11 and requested that Korarise enter Circle K to purchase gas, but he refused. Korarise advised Tasia to enter the store and stated "I don't care what you look like", referring to her fresh injuries. While inside she requested the employee to call 911 due to her believing that her life was in danger. Tasia last observed the firearm on Korarise's lap while parked at Circle K. Tasia was transported by Flagler County Fire Rescue to Advent Health Medical Center, 1 Advent Health Way, Palm Coast, FL to treat her injuries. Tasia completed a Domestic Violence Assessment and Statement Form and a Victims Right to Confidentiality Form. Tasia was also provided with a Florida Domestic Violence Rights and Remedies Law Brochure. Photographs of Tasia's injuries were captured.

The vehicle was pursued from Circle K eastbound on Palm Coast Parkway to Interstate 95

Southbound. The vehicle exited Interstate 95 on the off ramp at Mile Marker 260 Westbound on US Highway 92. The vehicle traveled South on Tomoka Farms Road. Florida Highway Patrol conducted multiple PIT maneuvers until the vehicle eventually came to a final stop at Tomoka Farms Road and Pioneer Drive, New Smyrna Beach, FL. During the pursuit of Korarise, Deputies observed him throw an object outside the vehicle while in Volusia County. The object was unable to be identified or located. Florida Highway Patrol and Flagler County Sheriff's Office Deputies conducted a felony stop and secured Korarise. Florida Highway Patrol attempted to interview Korarise, but he refused to speak to Law Enforcement. The vehicle was removed from the scene by Universal Towing located in Port Orange, FL. See Florida Highway Patrol Case Number FHP 26ON0119523 for further.


Korarise struck a vehicle causing property damage while the pursuit occurred. See Flagler County Sheriff's Office Case Number 2026-000024971 for the crash report.

I made contact with Florida Highway Patrol and Flagler County Sheriff's Office Deputies at the location of the vehicle. I placed Korarise in the back seat of my agency issued patrol vehicle and transported him to Volusia County Branch Jail without incident.

Korarise did willfully flee or attempt to elude a law enforcement officer in an authorized law enforcement patrol vehicle with agency insignia and other jurisdictional markings prominently displayed on the vehicle with siren and lights activated and during the course of the fleeing or attempting to elude drove at high speed, or in any manner which demonstrated a wanton disregard for the safety of persons or property.

Korarise without lawful authority did forcibly, by threat, or secretly confine, abduct, imprison or restrain Tasia, against that person's will.

Korarise unlawfully, while driving a vehicle involved in a crash resulting only in damage to a vehicle or other property which was driven or attended by any person, and without stopping such vehicle at the scene of such crash or as close thereto as possible and without forthwith

returning to the scene and without making known to the persons present his/her full, true and correct name and address, did depart from the scene of such crash, before he/she fulfilled the requirements of Florida Statute 316.062.

Korarise did actually and intentionally touch or strike Tasia against the will of Tasia or did intentionally cause bodily harm to Tasia.

Korarise was arrested for Domestic Battery (F.S.S. 784.03.1), False Imprisonment (F.S.S. 787.02.2), Leaving the Scene of a Crash with Property Damage (F.S.S. 316.061.1), and Flee with Disregard of Safety to Persons or Property (F.S.S. 316.1935.3)

Seminole County Sheriff's Office was notified of the incident that occurred in Sanford and a welfare check was conducted on the shared child of Tasia and Korarise [REDACTED] at 4511 Richard Allen Street, Sanford, FL. See Seminole County Sheriff's Office Event Number 2026 0741101.

Due to the aggravated domestic violence charges that occurred in Seminole County, Seminole County Sheriff's Office Detective Guzman responded to Advent Health Medical Center to speak to Tasia and further investigate the charges of Aggravated Assault with a Deadly Weapon, Aggravated Battery with a Deadly Weapon, and Domestic Strangulation. See Seminole County Sheriff's Office Report Number 2026 00001393.

All documents will be submitted to Flagler County Records. All photographs captured will be uploaded to Evidence.com. The Department of Children and Families will be notified due to the domestic incident and both parties having a child in common.
