contact was made with CT's siblings, [REDACTED] (CRT) and [REDACTED]. According to CT, they were dropped off on a corner nearby by their mother, Sandra, who was done with them.

Deputy Drew responded to Advent Health North and was informed of the above. CT had left the hospital on foot and was attempting to walk to their residence, [REDACTED] Florida. Deputy Drew located CT at Belle Terre Parkway and Whipoorwill Drive and transported him back to Advent North for a medical evaluation.

The Department of Children and Families (DCF) was notified and responded. Deputy Drew spoke with DCF Child Protective Investigator (CPI) D. Lopez, who spoke separately with CT and CRT. The following is a summary of the fact-finding interviews conducted with all three (3) juveniles:

- CRT said this morning, she and her sister, TT, woke up late, and they rushed to get to work. While they were getting ready, CRT said Sandra Teague found out another one of their dogs had died and then went crazy. CRT explained that the other dogs are skinny, too, and she didn't believe it was a big deal. She began arguing with CT and Sandra about who was supposed to care for the dog.
- Deputy Drew spoke with CT, who advised that he woke up and found one of the dogs had died, as this was the second or third one that had died. The last time one of the pets died was a couple of months ago, and his sisters, TT and CRT, were blamed for letting it die of starvation and thirst. CT said Sandra loves dogs more than he and his sisters, and would rather spend time with dogs than with her children. CT added that today was the first time she dropped them off somewhere and made them get out, as she usually just locks them out of the house. When asked when the last time they (children) were locked out, and where they usually go, CT said his sisters will sleep outside all night, and he will leave and try to stay at a friend's house. CT explained further that Sandra locks them out of the home about every other day.



- TT informed deputies on scene that they had discovered that one of their family's foster dogs had passed away this morning (04/30/2026), and that Sandra was blaming it completely on the kids. TT stated this was Sandra's "last straw." TT stated her mom then drove them all to the hospital, verbally yelling at them to exit the vehicle. TT stated that she then began to put her shoes on. This is when Sandra stated that they cannot take their shoes because she "bought it for them" and that it was "hers."

Deputies were able to locate Sandra at her residence [REDACTED] and make contact. The following is part of Deputy Colubiale's supplemental narrative:

- "I then responded to the residence of [REDACTED] in an attempt to make contact with Sandra. I was able to observe Sandra sitting in her front yard, holding a 5-month-old baby that she had been babysitting. Sandra stated, "My daughter killed my dog last night." Sandra went on to explain that it was due to her daughter taking the dog out of her son's bedroom. Sandra stated that she is done with the kids and that she no longer wants to take care of them, stating, "They deserve someone that they will listen to." Sandra went on by stating her kids do not listen, don't do their schoolwork, and are constantly sneaking around at night trying to get onto Discord. Sandra stated that her daughters "shit in their yard" and that "you should see my clothes, she wipes her shitty ass on them." Sandra stated that whenever she goes grocery shopping, rather than the kids putting the groceries away, they had them all over the house. Upon asking what occurred today, she stated, "They have been warned that if they don't start doing what I ask, such as doing schoolwork, don't cut holes in my walls..." and that "I'm leaving, I'm going away... out of state, where no one can find me." Sandra stated that upon her asking how the dog was last night, "instantly, they lie." Sandra went on to explain how they "compulsively lie" and how she tried to get an answer out of them, which resulted in the juveniles starting to verbally fight. Sandra stated she was over it and dropped them off at the hospital. Sandra then stated that she has no idea where the dog is, and that it is inside the residence, where the other "five (5) big dogs and five (5) small dogs"

While speaking with Sandra, her dogs inside the residence began to get rowdy, so she then went inside the residence to attempt to quiet them. It is to be noted that the front door area reeked of garbage, feces, and possibly the deceased pet inside the residence. Upon exiting the residence, Sandra's foot was covered in what appeared to be animal or human feces. I was unable to determine due to the number of animals inside, or due to Sandra consistently stating that her daughters like to "shit" all in the house. Sandra then wipes her foot up her leg to remove the feces. I asked Sandra if she would like to go inside to clean whatever she stepped in, to which she stated she would scrub the whole floor later. Sandra allowed a German Shepherd (who had only three (3) legs) to exit the residence. The dog began to pant, sounding exhausted, and I asked Sandra if she had some water for the dog to drink. Sandra then pointed to the right side of the patio, stating, "Her water is over there; as a fact, she is drinking from it." Upon observation of "her water", it was a Conch shell, with green algae, and water from the rain in it.

Sandra then placed the 5-month-old baby she was babysitting down on a blue gymnastics mat, which was infested with flies. While speaking with Sandra, I was still able to observe the flies landing on the baby and Sandra."

The Major Case Unit was notified of the above and responded. DCF CPI Lopez and I, Detective Gordon, made contact with Sandra at the residence [REDACTED]. Sandra agreed to speak with me in reference to what occurred. Sandra explained that she has been having behavioral issues with all three (3) of the juveniles: CT, CRT, and TT. Sandra stated that her children do not listen to her and do not assist with chores. Sandra reiterated many of the statements made to Deputy Colubiale. Additionally, when asked about the deceased dog,

Sandra explained that the puppy was CT's room but had been taken out by one of her daughters. This morning, Sandra discovered that the puppy was dead. When asked where the deceased dog was located, Sandra said that it was in the garage of the residence. Sandra was unsure if the dog was killed or not. During our conversation with Sandra, she claimed that CT had told her that hospitals are safe locations where she could legally drop them off. I asked Sandra if she had called law enforcement for assistance, and she said she had not. Sandra did explain that she messaged her ex-husband, David, about needing help and having dropped the children off at a hospital. Sandra allowed me to view messages on her phone, which were from today (04/30/2026). Following this, at 1709 hours, Sandra was placed under arrest. Sandra's phone was seized, incident to arrest.

It should be noted that multiple Ring Surveillance Cameras were on the exterior of the residence [REDACTED]

The following information was obtained during a neighborhood canvass:

- Georgie La Pierre Cutts explained that the residents at [REDACTED] argue often. Years ago, Georgie and her family were cordial with Sandra. During this time, Sandra mentioned that her daughters had been stealing her sweets, and this caused her to place locks on the outside of their bedroom doors. Georgie provided footage that she had taken of one argument she overheard on April 23, 2026, at 1817 hours. In the footage, a female, whose voice is consistent with that of Sandra's, is yelling, "If you come in my fucking house, I'll fucking kill you". Additional footage was provided from other dates of a female yelling. In some of the footage from April 14, 2026, at 1403 hours, a female, whose voice is consistent with that of Sandra's, is yelling at someone, "you and your sister's...", inferring that she is yelling at the children.
- Kaitlyn Troina explained that a few years ago, either TT or CDT had asked her daughter, who is the same age, to come over and play. According to Kaitlyn, when her daughter returned home, she said that Sandra had locked them outside the entire time.

Due to this, Kaitlyn no longer allows her daughter to go to the [REDACTED] residence. Detective Costello obtained a search warrant for the residence, which was signed by Honorable Judge Totten.

Detective Costello and I, alongside CSI Supervisor MacLellan, CSI Massa, and CSI Butler, executed the search warrant on the residence. As of 05/01/2026 at 0430 hours, 44 live dogs, 3 live pigs, 1 live cat, and 1 live snake have been recovered from the residence with the assistance of Palm Coast Animal Control. There are what appear to be multiple deceased animals within kennels on the property. There is fecal matter throughout the residence on the floors and walls. The search warrant execution is still active and ongoing at the time of authoring this arrest affidavit.


According to the Dissolution of Marriage between Sandra and David Teague (Flagler County, Florida Case Number 2016 DR 914), referencing the three (3) involved juveniles:

- "Parental Responsibility and Decision Making: The parties shall have shared parental responsibility and shall retain full parental rights and responsibilities with respect to the minor children".
- "Designation of Custodian for Other Legal Purposes: The Mother shall be designated as the custodian of the child for the purposes of all other state and federal statutes which require a designation or determination of custody."

It should be noted that David Teague currently resides in New Jersey. DCF contacted David to inform him of the incident and the need to shelter the juveniles. According to DCF, David is in the process of coming to Florida to take custody of the juvenile victims.

At this time, Sandra Teague appears to be the sole caretaker of CT, CRT, and TT.

Due to the information above, there is probable cause to believe the following:
