

Count 1 on or about April 30, 2026, Sandra Marie Teague, in the County of FLAGLER and State of Florida, did fail or omit to provide C.D.T, a child with the care, supervision, and services necessary to maintain the child's physical and mental health, including, but not limited to, food, nutrition, clothing, shelter, supervision, medicine, and medical services that a prudent person would consider essential for the well-being of the child, and said Sandra Marie Teague was the child's parent, an adult household member, or other person responsible for the child's welfare, {or} failed to make a reasonable effort to protect C.D.T. a child, from abuse, neglect, or exploitation by another person, and Sandra Marie Teague was the child's parent, an adult household member, or other person responsible for the child's welfare, contrary to Florida Statute 827.03(2)(d) and (1)(e). (3 DEG FEL),
