girlfriend, who was later identified as Kristen S. Gunnarsson (W/F, 02/14/1982) by her Florida driver's license. Cesar was concerned for Kirsten's welfare as she was texting him while locked in the bathroom of her residence. Cesar explained to LEO that Kristen asked him to call 911 because her fiancé would not let her leave the residence. Kristen's fiancé was later identified as Tony Lagano (W/M, 07/14/1982) from prior calls for service at the location above. It should be noted that there have been approximately 16 calls for service at this location since April 2026.

Upon arriving at the residence, I made contact with Tony, who met the deputies at his front gate. Tony was immediately uncooperative with deputies, not allowing them to approach the residence. Tony did not want deputies to "breach the fence," as he would continuously repeat while on scene. Tony would state that he is "war-ready" if deputies were to approach the front fence area.

I then made contact with Kristen, who exited the residence. Kristen was visibly shaken and began stating that this was the first time he had let me out of the house. Kristen then showed deputies the video of her attempting to leave the residence, which she had sent to Cesar. The 1-minute and 22-second video showed the following:

At approximately the 30-second mark, Kirsten is seen attempting to leave the residence with a basket full of clothes.

- Tony enters the sliding glass door and yells, "Back the fuck up, back the fuck up away from me right now."
- Kristen replies with, "I need to get outside."
- Tony screams, "You're not getting anywhere your staying here."
- At the same time, Tony slams the door shut behind him

- Tony screams, "we ain't doing this shit no more."
- Tony then uses his left hand and strikes the white basket Kristen is holding, causing it to fall back into her. Kristen began to lean forward due to the force used.
- Kristen yells, "Stop!"
- Tony screams, "Fucking get your shit and put it back where it goes."
  - Tony then slams the sliding glass door and attempts to lock it, keeping Kristen inside the residence.
- Tony again states, "You know what, I'm gonna go outside and you are staying inside. When you are ready, send a text to Cesar saying Tony is Bruce Wayne and you are the Joker."
  - Tony then uses his body to block the doorway and exits the slider by slamming it shut.
- Tony states while outside, "Now fuck off!"
  - Tony then walks around the porch area and is seen kicking the glass slider twice with enough force that the glass begins to bend and wobble both times.
- The last seconds of the video are shown with Tony holding his hands out, yelling something towards Kristen, which is inaudible.

It should be additionally noted that the sliding door is the only way in or out of the residence.

Kristen also stated that after the video ended, Tony attempted to smack the phone out of her hand and grab it, but she would not let him. Kristen stated that due to his current

behavior, she didn't know what was going to happen later if she stayed. Kristen was asked why she confided in Cesar to call 911 instead of herself while inside the residence. Kristen explained that she was scared that Tony would hear her, and she did not want any further retaliation from him. Kristen also explained that in a previous altercation prior to the video, Tony again blocked the door, not allowing her to leave the residence. Kristen stated that the other front door does not open, and the only access to the residence was through the glass sliding door. Kristen explained that she currently lives at the residence and does not feel comfortable leaving. Kristen stated that she and Tony have been dating since March 2026 and have been engaged since the beginning of May. Kristen also advised Deputies that she believes she may be pregnant with Tony's child, but did not confirm this information.

While deputies were talking to Kristen, Tony began calling 911 approximately nine (9) times. Tony would state on the 911 call that the "cops are interrogating my fiancé and she is going to have a miscarriage." Tony would further state on 911 that the "cops are trying to kill me". At no point in time was Kristen actively in distress while speaking to deputies, and no active life-threatening emergencies were taking place while deputies were on scene.

Due to the information provided up to this point, and Tony's extreme behaviors. It was decided that Tony was going to be placed under arrest.

Deputies then observed Tony leaving the residence with his dog. As Tony saw law enforcement approach him, he returned to the fence line and began yelling at the deputies not to approach his gate. Tony threatened the deputies, "I'll get really stabby stabby, you don't want that. I'll take your gun out and shove it up your ass and pull the trigger. I could be like Rambo, but I don't want that," at the same time, Tony began dropping his hands towards his waistband area. As deputies began to de-escalate the situation, Tony became upset with the deputies' presence.

Deputies then entered through Tony's gate and told him he was under arrest at the same time Tony stated, "no, no, no" and began running to the rear of his property. A brief foot

chase took place in Tony's yard until he ultimately gave up in the rear of the residence. Tony was then placed in handcuffs.

Tony was then placed in the rear of my agency-issued vehicle. While enroute to the Flagler County Inmate Facility. Tony began spitting continuously for approximately 40 minutes. Tony would aim the spit directly at the clear sliding partition towards me. Tony then unbuckled himself from the rear seat and turned his handcuffs around so they were facing in front of him. As the spit began dripping from the rear partition, Tony used his finger and wrote "hi pig." Tony would also kick the metal partition multiple times. He was then transferred to booking deputies upon arrival at the jail.

Kristen refused to complete any paperwork while on scene.

After all the information was gathered from the scene, Tony is being charged with the following:

- Domestic Battery (F.S.S. 784.03.1.a.2)
- False Imprisonment (F.S.S. 787.02.2)
- Resisting without violence (F.S.S. 843.02)
- Threat to Law Enforcement (F.S.S. 836.12.2.a)
- Misuse of 911 services (F.S.S. 365.172.14.a)

A criminal history check was completed for Tony, and the following was found:

- 02/12/2009 – Domestic Battery / Abuse of an elderly person or disabled adult (2009 CF 000160)
- No Information – 03/06/2009
